As, In order to curb the ongoing Corona Pandemic spread, various remedial measures are being undertaken at Government level. As a part of the same, in Sangli rural areas too, preventive and medical treatment work is being carried on. In present condition looking at the increasing number of Corona patients private hospitals, nursing homes and multi specialty hospitals registered under Nursing Homes Registration Act, 1949(Amendment) 2005 are expected to treat the patients of Covid. and

As, Dhanvantari Hospital, Ashta, Tal. Walwa, Dist. Sangli affiliated to Hon. Shree Annasaheb Dange Ayurved Medical College operated by Sant Dnyaneshwar Shikshan Sanstha is a private hospital registered under Nursing Homes Registration Act, 1949(Amendment) 2005.

Hence, I Dr. Abhijeet Choudhari, Collector and District Magistrate Sangli, by the adhering to the powers conferred on me order that, Dhanvantari Hospital, Ashta, Tal. Walwa, Dist. Sangli affiliated to Hon. Shree Annasaheb Dange Ayurved Medical College operated by Sant Dnyaneshwar Shikshan Sanstha immediately be reserved as a Dedicated Covid Hospital to treat Covid patients. Accordingly, I.C.U. and isolation wards for Covid patients be started immediately in your hospital and Covid patients be given treatment in your hospital. For that, the Covid patients are to be treated as per the procedure issued by the Medical Education Department and Public Health Department, Government of Maharashtra, Mumbai.

This order is to be implemented immediately. If it comes to notice that this order is being violated or there is negligence or delay in the execution of the order there will be legal action taken against you under Art. 51 of the Disaster Management Act, 2005, and Epidemic Disease Act, 1897 and Section 2(a)(iii) Maharashtra Essential Services Maintenance Act, 2005. Also it is to be noted, if it is comes to notice that any of your employees are not present or are not

carrying out their duties, they too will be prosecuted as per the above mentioned Acts.
